#### **DNR Grant**

We did receive an application for the 2022 VFA DNR grant. I did submit the grant application for various hand tools and equipment in the total amount of approximately \$4500.00. We were notified we did receive this grant. We have been working on the

equipment list and will be working toward ordering the equipment. We have ordered some of the equipment and some is currently being delivered.

#### 2021 AFG Grant

We were fortunate that they extended the grant application deadline to January 21, 2022. I submitted the application for a new fire engine to replace Engine 1 with an amount of \$375,000. Our cost share if awarded is \$17,857.14. The application was submitted on January 18, 2022. **Waiting on award announcement. Announcements have started, no word yet.** 

#### **Hannahville Grant**

We put in a grant for some mechanic tools for the station. Received notification we were awarded the grant. All of the tools are purchased and in. The final grant paperwork has been submitted to Hannahville by Rich. This closes out this grant.

The grass has been slowing down. Park is quiet and the restrooms have been staying relatively clean.
