GENERATOR

Chris got an updated quote from the company we've been dealing with for the Generator from \$ 17,500.00 to \$19,790.04 for the changes we wanted. They are requesting 10% own now to hold it and another 40% when the installation is started. A motion was made by Chris to approve this generator with Kevin seconding.

ROAD COMMISSION ANNUAL REPORT

Jim Moraska attended the Road Commission's annual meeting in Stephenson on Jan 25th at 8AM. They gave a report on the roads that were repaired last summer. US 2 and 41 will have a new cover layered down from our Township hall to Bark River. County road 388 is in need of repair or it'll have to be returned back to gravel. A motion was made to repair county road 388 by Kevin and was seconded by Chris. All in favor, aye, motion carried.

NEW BUDGET FOR REVIEW

The Board reviewed the new proposed budget.

RESOLUTION

The whole county is under the control of the equalization dept. People are having serious issues with this director. It was brought it up to the County Administrator. Several Townships have drawn up a resolution and this document was signed by the Spalding Township Board asking for her resignation.

CRUSHED GRAVEL

We got a proposal from North Star Crushing to crush 10,000 yds of gravel, however the person we were going to get the gravel from has a conflict of interest. At the time we arranged to get this gravel 2 years ago has now been elected into the Road Commission and it wouldn't be right to get this gravel from him. We are looking into acquiring gravel from a new source.

JACKIE SCHAFF

Jackie is looking into setting up a Farmers Market at Veterans Park this coming summer allowing the selling of homegrown vegetables and handcrafted goods. She has a lot of great ideas to make this idea happen. The Township will be looking into the legal aspects of allowing this.
